1. Definition and Purpose

The Best Annual Reports Awards is an annual competition organized by The Hong Kong Management Association. The purpose of the Awards is to encourage the publication of timely, accurate, informative and well-presented annual reports for shareholders, stakeholders, employees and others who may have an interest in the performance and activities of the organizations in question and to recognize and honour the organizations for their exemplary achievement in producing such reports.

2. Categories of Awards

Awards will be offered in the following two categories:

- General
- Non-profit Making and Charitable Organizations

2.1 Overall Awards

Gold, Silver and Bronze prizes and Excellence Report Award will be awarded in both categories. An "Island Shangri-La, Hong Kong Best Report Award" will be awarded to a company / organization if the Panel of Adjudicators finds that its annual report has sufficient merit to deserve the prize.

2.2 Sub-Category Awards

The following sub-category awards will be offered to recognize other exceptional achievements:

- Excellence Award for Charitable Organizations;
- Excellence Award for First-Year Listed Companies;
- Excellence Award for GEM Entries;
- Excellence Award for H Share & Red Chip Entries;
- Excellence Award for Small Size Entries;
- Best New Entry;
- Citation for Design;
- Judges' Special Award

For the purpose of these awards:

- small size entries are defined to be any companies / organizations with no more than 250 full-time employees; and
- charitable organizations are defined as organizations which are exempted from tax under Section 88 of the Inland Revenue Ordinance.

Please note that winners of overall awards (i.e. Best, Gold, Silver, Bronze and Excellence Report Award) would not be included in the assessment for Citation for Design and Judges' Special Award as they have already attained an outstanding level in each of the judging criteria.

2.3 Special Awards for Environmental, Social and Governance (ESG) Reporting

Special Awards for ESG Reporting will be awarded to recognize companies and organizations which show outstanding ESG disclosure. The awards include Best ESG Reporting Award ("Industry")*, Excellence Award in ESG Reporting, Certificate of Excellence in ESG Reporting and Citation for Online ESG Reporting ^{New}. Participating companies / organizations can choose to merely join this special award.

4. Method and Rules of Judging

Entries will be judged in accordance with the Schedule of Criteria. The Panel of Adjudicators will not only judge individual reports for their compilation with relevant standards or best practice but also take note of the sufficiency and relevance of the contents as well as the understandability and the manner in which information is presented.

The decision of the Panel of Adjudicators will be final and binding. In the event of the adjudicators being unable to reach a decision or find entries of sufficient merit, the Panel may withhold any or all of the awards at its absolute discretion.

SCHEDULE OF CRITERIA

Special Awards for ESG Reporting

General & Non-profit Making and Charitable Organizations

 - c. Governance such as governance structure, sustainability responsibilities, governance process, contingency planning and risk management

5. Eligibility for Entry

Any company or organization listed in Hong Kong, or with its registered office or a principal place of business in Hong Kong is eligible to enter the competition. (The Hong Kong Management Association reserves the right to decide on eligibility for entry.)

6. Entry Requirements

Best Annual Reports Awards

Participating companies or organizations are required to submit the below documents:

1. A completed online entry form
2. Electronic copy of the latest published annual report and financial statements of the company or organization in respect of any financial year ended in either 2023 or during 2024
3. 4 hard copies of the full English / Bilingual annual reports and financial statements
4. 2 hard copies of Chinese version of full annual reports and financial statements (if applicable)
5. A paragraph of 100 words maximum as a supplementary document highlighting the special areas which they have done particularly well and have shown significant improvements (for nomination for Judges' Special Award)

Special Awards for ESG Reporting

Participating companies or organizations are required to submit the below documents:

1. A completed online entry form
2. Electronic copy of the latest issued ESG / Sustainability / CSR Report
3. 4 hard copies of the English / Bilingual ESG / Sustainability / CSR Report (if applicable)
4. 2 hard copies of Chinese version of ESG / Sustainability / CSR Report (if applicable)

The above documents should be submitted online by 5 July 2024.

For those companies or organizations whose balance sheet date is 31 March 2024 or later, the latest published annual report and financial statements must be submitted by 12 July 2024, but the completed entry form must be submitted online by 5 July 2024.
